### **GOAL:**

To strengthen the capacity on preventing and controlling Drug Resistant Tuberculosis in Penal institutions according to the most updated, evidence-based, WHO and internationally-recognized policies and guidelines.

## OUTCOME:

By the end of the course, participants will have a better understanding on implementation of effective TB control interventions in Penitentiary institutions including implementation of new TB diagnostics, drugs and regimens.

## FACULTY:

Staff from WHO Headquarters (Switzerland) and Regional Office for Europe (Denmark); WHO Collaborating Centre for TB/HIV and TB Elimination (Italy); Regional TB Infection Control Centre (Russia); Partners in Health (USA); Stop TB Partnership (Switzerland); MSF; State Pharmacovigilance Centre (Belarus); the Main Medical Department of the Ministry of Justice (Azerbaijan), Specialized Treatment Institution for detainees with TB (Azerbaijan), as well as independent international TB consultants.

## METHODOLOGY:

The course consists of lectures, discussions, practical exercises, group work, visits to penal institutions to observe TB screening, diagnostics and treatment in corrections.

## TRAINING LANGUAGE:

The course languages are English and Russian.
